Regular Agenda Items:

1. To consider a request from Eric & Amanda Tegels, Sauk Centre, MN from Section 6.7.5D of the Stearns County Land Use & Zoning Ordinance #439 to expand a less than 10 animal unit facility to a greater than 10 animal unit facility that is 175 feet from a residence. Said Ordinance requires a 700 foot setback to a residence from an animal feedlot that is registered for 10 animal units or more. Affected property: 44.06A NE4NE4 & E 156' of NW4NE4, Section 20, T126N, R34W, Sauk Centre Township. Property address: 41669 State Highway 28, Sauk Centre, MN.
Approved as requested.
2. To consider a request from Gregory & Margaret Spanier, Richmond, MN from Sections 9.9.9A(3)&10.2.11A(1)(a) of the Stearns County Land Use & Zoning Ordinance #439 to construct a second story addition over the attached garage 3 feet from the Right of Way of Langevin Drive, a Township Road, and to construct a screened deck 88 feet from the Ordinary High Water Level of Cedar Island Lake, classified as a Recreational Development Lake. Said Ordinance requires a structural setback of at least 30 feet from the right of way of a Township Road and a structural setback of at least 100 feet from the OHWL of lakes classified as Recreational Development Lakes. Affected property: Lots 4 & 5, Block 2, Jody Estates First Addition, Section 32, T123N, R30W, Wakefield Township. Property address: 20313 Langevin Drive, Richmond, MN.
Approved as requested.
3. To consider a request by Derek Schmidt, Clearwater, MN on behalf of James & Janel Honer, St. Augusta, MN from Section 10.2.11A(1)(a) of the Stearns County Land Use & Zoning Ordinance #439 to construct a single family residential dwelling with an attached garage 166 feet and to leave as constructed a 26 foot by 52 foot detached accessory structure 175 feet from the Ordinary High Water Level of Lynden Lake, classified as a Natural Environment Lake. Said Ordinance requires a structural setback of at least 200 feet from the OHWL of lakes classified as Natural Environment Lakes. Affected property: 13.30A NE4SE4 LESS N 880', Section 19, T122N, R27W, Lynden Township. Property address: 16284 5th Avenue, South Haven, MN.
Approved as requested.

4. To consider a request from Trevor & Tiffany Akervik, Sartell, MN from Section 7.26.1B of the Stearns County Land Use & Zoning Ordinance #439 to have an automatic lockable pool cover to secure unauthorized access to an in-ground swimming pool. Said Ordinance performance standards for swimming pools requires the pool itself or yard around the pool shall be enclosed by a wall, fence or combination thereof, which is at least six (6) feet in height with a self-closing gate capable of being secured with a lock so as to prevent uncontrolled access. Affected property: Lot 1, Block 1, Prairie Grass Estates, Section 29, T126N, R28W, Brockway Township. Property Address: 5501 Prairie Grass Drive, Sartell, MN.

Approved as requested with the condition that the model of the pool cover and confirmation that the pool cover complies with ASTM F 1346.91 is provided to Environmental Services.
